March Speaker: Robert F. Klueger

Topic: The Failure of the Treaty of Versailles... And What it Portends for Right Now

In January 1919, the three most brilliant and accomplished men of their age - Woodrow Wilson, Britain's Prime Minister David Lloyd George, and France's Georges Clemenceau - met in Paris to hammer out the treaty that would end "the war to end all wars." It did not, and the vindictive and counterproductive disaster that these intelligent men produced may well have paved the way for the Second World War.

How did it happen? How did three statesmen - who knew better - allow themselves to be so misguided? How could foreign policy fail so grievously?

In his recent book Wilson, Clemenceau, Lloyd George and the Roads to Paris, Mr. Klueger explored the personal histories of the principals and temperaments of the nations they led, in order to find the answers. The Peace Conference that culminated in the Treaty of Versailles is an object lesson in the failure of statesmanship. Its lessons resonate today. Mr. Klueger will provide a slide presentation of the participants at the Peace Conference to accompany his presentation.

Robert F. Klueger spent most of his career as a tax lawyer in Los Angeles. He obtained a B.A. in Political Science and International Relations from the University of Pennsylvania (1967), a J.D. from Fordham Law School in 1973, and an M.A. in Taxation from the University of Denver Graduate Tax Program (1980). Sandwiched in between, he was a communications officer in the United States Navy. The highlight of his career as a tax lawyer was arguing Brockamp v. United States before the United States Supreme Court, a case that resulted in a change in the Tax Code. Mr. Klueger authored a number of legal texts before Roads to Paris, including Buying and Selling a Business, Mergers and Acquisitions: a Step-by-Step Guide, and The Guide to Asset Protection. Mr. Klueger turned to the study of history upon his retirement from the practice of law in 2016. Robert Klueger is a valued member of ARAS.

Because of the wealth of talent and interesting lives led by our very diverse membership, we continue our series of stories focusing on the lives of our members. It is our hope to eventually cover every member.

"Amicus Personae" – James A. Prozzi Member of The Association of Retired Attorneys of Sarasota

Jim Prozzi has spent the past forty-five years first studying, then practicing, and now teaching labor and employment law.

In 1976, during his third year at the University of Pittsburgh School of Law, he was the research assistant to the professor who had taught labor law for many years. He took that labor law class, as well as a class on employment discrimination and a seminar on labor arbitration. He knew that this was the only area of law in which he wanted to practice.

Jim was fortunate enough to follow that passion for the next forty-three years. He spent his entire legal career, from 1977 until 2020, practicing labor and employment law on behalf of management. He started with an experienced sole practitioner in Pittsburgh, and after ten years, he joined the Pittsburgh office of Jackson Lewis, the country's second largest labor and employment "boutique' law firm. During these years of active practice, Jim's labor law work included union negotiations and arbitrations, as well as National Labor Relations Board (NLRB) elections and hearings. His employment law practice during these years included numerous trials(both jury and non-jury), as well as a sub-specialty of advice and litigation in the area of federal wage and hour law.

Both aspects of his practice involved significant appellate work: he has argued more than 30 cases before the U.S. Courts of Appeal for the Second, Third, Fourth, Sixth and Eighth Circuits.

During his years of active practice. Jim regularly published articles on labor and employment law. (He has an article which is to be published in next few months in the *ABA Journal of Labor & Employment Law* about the Pitt Law professor who became the first Chairman of the NLRB in1935). But he was always interested in the possibility of teaching in this specialty and giving something back to a profession which he loves. In 2013, he was able to do that when he began teaching labor law at Pitt Law as an adjunct professor, the same course which he took as a third- year student many years before.

Jim retired from his firm in early 2020, and he and his wife, Margaret Bryant (also an attorney and a new member of ARAS) became full-time residents of Sarasota, having been part-time residents since 2005. Teaching at Pitt Law was no longer possible with his retirement, but Jim was fortunate to be asked to teach employment law at Stetson University College of Law in Gulfport as an adjunct professor. He is now beginning his third year of teaching employment law at Stetson.

Jim always likes to tell his students what Justice Oliver Wendell Holmes once said, which is that "life is action and passion ... and a person should therefore try to share the passion and action of their time". Even though Jim's "action" years of practice are behind him, his "passion" for teaching the next generation of labor and employment lawyers continues.
