“THE PRACTICE OF LAW IN A COMBAT AREA” (Vietnam 1970–71)

Richard Bruning earned his BBA and JD at the University of Iowa and was admitted to practice in Iowa and before the Court of Military Review, Court of Military Appeals, Federal Court of Claims, and US Supreme Court. He served in the US Army in the Judge Advocate General’s Corps and as a Federal (Military) Judge in the 23rd Infantry Division in Vietnam (1970–71), retiring as a Lt. Colonel after 23 years. He was subsequently VP and General Counsel of Martin Marietta Aerospace Missiles and Fire Control Co. (now Lockheed Martin) for 26 years. He was also a Professor of Law in the Judge Advocate General’s School at the University of Virginia Law School.
