## June Speakers

#### ABOUT JIM BENNETT:

Born, raised, and public schooled in Montclair, New Jersey, Jim Bennett graduated from Princeton University and Stanford Law School, going on to clerk for the Hon. John J. Francis of the Supreme Court of New Jersey. After several years in private practice in Newark, NJ, he went in-house as international corporate counsel for twenty years at a number of Fortune 500 companies until his final position as Vice President and International Counsel of the Revlon Health Care Group was eliminated by acquisition. He then went out on his own ultimately acting as outside general counsel for a number of corporate clients and individuals, before serving as Interim Executive Presbyter of the Presbytery of Southern New England. Moving to Florida in 2006, he retained his position as EVP, General Counsel and Secretary for Palladium USA, Inc., the local subsidiary of a European real estate developer, now engaged in tax-credit housing in Texas. He is on the board of WEDU, the Tampa-based public TV/streaming media company under the PBS system, and was a member of the Venice City Council from 2009 to 2015, serving as its representative to the Sarasota-Manatee Metropolitan Planning Organization, and its chair for the 2014-15 term.

#### ABOUT JOHN ALEXANDER:

John is a graduate of Ohio State and Case Western Reserve University, where he was a member of the law review. He clerked for a federal district court and then engaged in general practice in Ohio.

#### ABOUT RICHARD WEINGARTEN:

Richard received his BA and JD from St. John's University. He has held a variety of legal and executive positions including City Judge in Yonkers, NY, Executive Director of the Yonkers Industrial Development Agency and Adjunct Professor at Long Island Graduate School of Community Health and Health Administration. He also served as a lieutenant colonel in the US Air Force Reserves.
